Regular Meeting

March 20, 2023

The regular board meeting was called to order by President Justin Clark at 5:30 p.m. in room #109. Board members present were Tim Backer (via phone), Phil Barnett Justin Clark, Brandon Kampman and Shelley Maiers; others present were Superintendent Mark Olmstead, Business Manager/Board Secretary Shellee Bartlett, Principal Kristi Hannemann, Heather Foster, Ben Lovrien and Matt Wilken.

Moved by Kampman, seconded by Maiers, to approve the agenda. Carried unanimously.

Public hearing on 2023-24 calendar was called to order at 5:31 p.m. Superintendent Olmstead reviewed the proposed calendar. No public response was received. The meeting was closed at 5:32 p.m.

Moved by Barnett, seconded by Kampman, to approve the minutes from February 20, 2023 and February 28, 2023 meetings. Carried unanimously.

Moved by Maiers, seconded by Barnett, to approve February 2023 financial reports and March 2023 monthly bills. Carried unanimously.

Moved by Kampman, seconded by Maiers, to approve the sharing agreements with North Butler CSD for shared Superintendent, Business Manager, HR Director, Librarian.. Carried unanimously.

Moved by Maiers, seconded by Backer, to approve the classroom furniture @ \$146,970 from Value InspirED Products & Services. Carried unanimously.

Moved by Kampman, seconded by Maiers, to approve the art room furniture @ \$11,121 from Value InspirED Products & Services. Carried unanimously.

Moved by Maiers, seconded by Barnett, to approve the 2023-24 IAEP Coop purchasing program for school food service. Carried unanimously.

Moved by Barnett, seconded by Maiers, to approve ratification of the 2023-24 negotiated agreement with the Clarksville Education Association and issuance of contracts. Carried unanimously.
