Regular Meeting

October 19, 2020

The regular board meeting was called to order by President Justin Clark at 5:30 p.m. Room #109. Board members present were Justin Clark, Phil Barnett and Brandon Kampman along with, Superintendent Joel Foster, Board Secretary/Business Manager Shellee Bartlett, Bob Bartlett, Heather Foster, Ross Timmermans, Scott McCubbin, Mike Tobian and Bethany Carson. Board members absent: Tim Backer and Shelley Maiers.

Moved by Barnett, seconded by Kampman, to approve the agenda. Carried unanimously.

Moved by Barnett, seconded by Kampman, to approve minutes for the September 21, 2020 & September 24, 2020 board meetings. Carried unanimously

Moved by Kampman, seconded by Barnett, to approve September financial reports and October monthly bills. Carried unanimously.

Moved by Kampman, seconded by Barnett, to approve the following recommendations: Debbie Schellhorn, part-time media associate @ \$12.00 per hour; Volunteers: Scott McCubbin, girls basketball coach, pending paperwork. Carried unanimously.
